INSTRUCTIONS FOR APPLYING FOR GRADUATE GRANTS

The Gundaker Foundation offers several one-year Graduate Scholarship Grants for post-baccalaureate studies in graduate and professional Schools. Gundaker Graduate Grants are renewable provided that recipients resubmit *all* application materials, receive the endorsement of a District 7450 Rotary Club, and are selected by the Gundaker Foundation for an additional award.

ELIGIBILITY

Candidates may be graduating college seniors, other persons seeking admission to graduate or professional schools for the first time, or those already enrolled in a post baccalaureate institution. Students who are residents of the 7450 Rotary District or enrolled in an institution located within the District are eligible to apply. The District includes all of Philadelphia County, much of Chester, Delaware, and Montgomery Counties, and part of lower Bucks County. Rotarians and members of their immediate families are not eligible for these grants.

SELECTION CRITERIA

Qualifications for these grants include high academic achievement; a record of leadership in school, community, or other settings; and evidence of involvement in giving service to others. Financial need is also a consideration. To receive the funds, the selected applicants must enroll in a graduate program during the fall term of academic year 2016-2017, either as new or continuing students. CANDIDATES MUST PLAN TO ENROLL FULL-TIME.

APPLICATION PROCEDURE

Candidates apply for a Gundaker Graduate Grant through their local Rotary Club. *All application materials must be submitted to the club no later than **Friday February 12th, 2016.***

A list of the Rotary Clubs in District 7450, with the Club Gundaker Director's name and contact information, can be found at www.rotary7450.org/gundaker/programs. If you are in doubt about the Club to which you should apply, contact the Gundaker Director of the Club which you think is correct and ask his/her advice.

All applications *must* include the following:

- Application form.
- An essay (no more than three pages) describing your academic and service activities, your intended goals, and how you meet the qualifications for the award. You may also include a copy of your résumé.
- Official transcripts of all *undergraduate and graduate* institutions the candidate has attended.
- Signed affidavit from the Financial Aid Director at the university which the applicant intends to attend attesting to the total costs of attendance for the coming year, the amount of aid the applicant anticipates committing from his/her own or his/her family's resources, and other sources; and the amount of remaining financial aid needed.
- A statement from the Dean (or appropriate officer) of the applicant's current or last school affirming that he or she is in good academic standing and is free from disciplinary sanctions.
- A recommendation letter from a person who attests to the candidate's leadership and/or service activities.

SELECTION PROCEDURES

1. Candidates email/mail their application documents to the GUNDAKER DIRECTOR of their local Rotary Club by **Friday February 12th, 2016**.
2. Local Rotary Clubs receive applications and select candidates they will sponsor for grants.
3. Application materials for the selected candidates are forwarded to the Gundaker Foundation Graduate Grant Committee no later than **Thursday March 10th, 2016**.
4. The Gundaker Foundation Graduate Grant Committee interviews finalists in April. Announcements of grant recipients are made in June. Grant payments are made in August/September for the start of the fall term. Payments are normally made jointly to the recipient and university.
